The Xperia Arc, also known as Xperia T, was the first smartphone running the Android operating system and was announced at the MWC 2011 on February 24, 2011. It was released on February 25, 2011 in several countries. It is marketed as Sony Ericsson's flagship model, as the Xperia X10 is considered as the flagship for Sony Ericsson. The Xperia Arc is the first Android smartphone to be marketed with Android 2.1 (Eclair), with a 3.7 inch AMOLED display. The smartphone is available in three versions, the LT17i, LT18i and LT19i. On release, the Xperia Arc was criticized for its long boot times, problematic touchscreen, and by some for its lack of a fingerprint sensor, because the fingerprint reader is only available in the LT17i model, along with the lack of music player. The Xperia Arc is currently still sold by Sony, but has not been replaced. In September 2011, Sony Ericsson announced that the Xperia Arc would be replaced by the Xperia Ray. The Sony Xperia Ray (LT20i in South Africa) has since then been sold worldwide. In October 2011, the Sony Xperia Arc was succeeded by the Sony Xperia Play, an Android media console. She added that the family is “very relieved by the news that he has been released from the custody of the courts and from Guantanamo, that he will be able to leave Afghanistan, and that he will be reunited with his children.” The family’s lawyer, Pardiss Kebriaei, said the family was seeking permanent residency in the United States. “I can only imagine how proud my client’s father is,” she said. “He’s just relieved that this nightmare is over.” Mr. Qahtani, who had been in legal purgatory for four years, told The Associated Press that the case seemed to have ended “as long as I live.” His release, the first in the case since November 2009, was the result of concerted lobbying by the White House and the Obama administration, which pursued vigorous legal and political efforts to persuade the Obama administration to keep the case open even after the appeals of the first judge were rejected. In the face of the opposition of his own Department of Justice and the government of Afghanistan, President Hamid Karzai transferred the case to a court in Afghanistan. After a two-year legal battle, the case was heard in November by Judge Thomas F. Hogan, who had overseen the trial of the five detainees who were convicted in the military commissions, in military court. He ruled that the case should be tried in civil court. He ruled that the classified documents in the government’s hands from 2002 and 2003 provided “clear and convincing evidence” that Mr. Qahtani was an al-Qaeda operative and that he had aided and abetted the killing of one or both of the Sept. 11, 2001, hijackers. “The government has not introduced any evidence or provided any

colorable argument that the defendant did not know or could not have known that the pilots intentionally crashed their aircraft into the Twin Towers of the World Trade Center,” Judge Hogan wrote.
