The gastrojejunostomy (GJ) is a valid alternative to the usual approach of the reconstruction of the digestive tract after colectomy. This study was to report the results of 56 patients who underwent this operation. From 1989 until 1994, 56 patients who underwent a GJ after colectomy were followed up and included in this study. Surgical procedure was performed through the conventional laparotomy. The median age of patients was 64 years (35-85). Forty-two patients presented with a colonic carcinoma, four with an ulcerating colonic diverticulum, two with Crohn disease, one with acute appendicitis and one with an intestinal adenoma. Tumors located on the caecum included 44 proximal and 12 distal. The GJ was performed with an active stapler in 46 cases and with suture in ten. The time of jejunostomy was 100 days (4-330). The immediate post-operative morbidity was 20% (thirty-two cases) with two deaths from sepsis (3.6%). The median stay in the hospital was of 12 days (7-75). The median follow-up was of 16 months (3-49). The GI had to be retransferred after 2 weeks in six cases from peristalsis disturbances. There was no occurrence of death in the 6th month and the major morbidity was represented by the 20 cases of stoma related complications (6 anal obstructions (1 case), 8 prolapses). The GI is a useful procedure to overcome some technical problems of digestive tract reconstructions, especially in patients with pelvi-cecal diverticulosis.
